Emeritus Professor at the University of KwaZulu Natal, South Africa

Professor Vishanthie Sewpaul (PhD) is a globally recognized social work and human rights scholar, activist, and speaker, awarded three honorary doctorates. She served as President of the Association of Schools of Social Work in Africa (ASSWA), the Association of South African Social Work Education Institutions (ASASWEI), and the National Association of Social Workers, South Africa. Additionally, she was Vice President of the International Association of Schools of Social Work (IASSW). Her recent memoir is The Arc of Our Paths: Growing into Wholeness.



Dr. Lynne Healy, PhD, MSW

Emeritus Professor at the University of Connecticut School of Social Work

Dr. Healy has taught for over 30 years. She serves as the Main Representative to the United Nations for the International Association of Schools of Social Work (IASSW) and is a member of the NGO Committee for Social Development. She has served as Secretary and Vice President of the IASSW, Chair of the Council on Social Work Education (CSWE) International Commission and member of the CSWE Board, and held roles within the U.S. National Association of Social Workers (NASW). She has published extensively on international social work, human service agency leadership and management, ethics, and human rights. Her latest book is International Social Work: Professional Action in an Interdependent World.
